AREA OF COMPETITION:	DIVISIONS:	DETAILS:
Photogenic	All age divisions	Headshots taken by an official pageant photographer. Judged by a panel of judges on pageant day and printed in the program book.
Interview	Pre-teen, Jr Miss, Miss	Five-minute panel interview with judges. Judging focuses on personality, poise, speaking/conversational ability, and overall impression. Additional information provided at the Miss contestant meeting on July 28 th .
Opening Number	Pre-Teen, Jr Miss, Miss	Contestants will perform a simple dance routine and introduce themselves (name, age, town). Attire will be the official 2024 CCFSP T-shirt (provided at rehearsals), BLUE jeans (no rips) or APPROPRIATE length denim skirts, cowboy boots, and jewelry of choice. T-shirt will be white with pastel-colored lettering.
Formal Attire/Gown	Tiny and Little Miss	Gown/dress of choice. May wear "Sunday Best/Flower Girl" dress or pageant dress (no "heavy glitz"); dress may be short or long and have rhinestones/ruffles. Judging will focus on personality and overall impression.
	Young and Pre-Teen Miss	Gown/dress of choice, should be full-length. Judging will focus on appearance, gown, personality, and overall impression.
	Jr. Miss	Gown/dress of choice. Judging will focus on appearance, gown, personality, and overall impression. Gowns may be strapless and/or have a slit (should not come far above the knee).
	Miss	Gown/dress of choice. Judging will focus on appearance, gown, personality, and overall impression. Gowns may be strapless and/or have a slit (should not come far above the knee).
Personality Wear	Pre-Teen, Jr. Miss, Miss	Outfit of choice that best suits your personality. Fast-paced modeling to music. Please, no cocktail/formal/pageant wear.
On-Stage Question	Pre-Teen, Jr. Miss, Miss	An unrehearsed on-stage question to identify the impromptu public speaking ability of contestants. This will be during the TOP 5.

2024 CCFSP theme is Fair/Carnival - Contestants are encouraged (not required) to participate in styling their personality wear to match the 2024 theme!

SPECIAL INFORMATION:

- In the event of a tie during the tabulation of scores, all divisions will be broken using the highest overall impression score. For the Miss division, the judges will break the tie; all categories for The Miss division will be evaluated in breaking the tie.
- An announcement will be made when scoresheets will be available in the fair office (during fair week).

2024 PHOTOGENIC/PROGRAM BOOK PICTURE INFORMATION:

- Each contestant is required to have a headshot taken by the official photographer; this image will be used in the photogenic competition and printed in the program book. Starting this year, this service is FREE to our contestants – conditions listed above, under Photogenic Headshot Times (pg. 1) No outside photos allowed, including those from past fair pageants – NO EXCEPTIONS.

PORTRAIT SESSIONS/SCHEDULING:

- Jessica Findley Photography will be at the fair office to take contestant headshots; no complimentary headshot sessions will be available after JULY 28 2024.

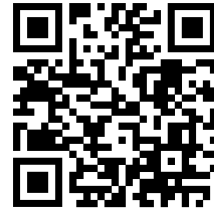

2024 CCFSP COMMUNITY SERVICE PROJECT INFORMATION: *NEW*

This year, in 2024, we will be partnering with The Miss Virginia Association of Fairs Community Service Initiative - Read to succeed! With that being said, each contestant will be required to collect/donate at least 5 new or gently used preK-1st grade reading level books. One of every five books will be gifted into Clarke County Public Elementary Schools. The remainder of books collected will be donated to our Miss division Queen to distribute throughout public appearances of her choice.

This year, a Community Service Award will be given to the contestant who collected/donated the most books throughout all contestants within the Clarke County Fair pageant system. Contestants may drop off book donations with the total number of books collected on rehearsals date (August 2nd & August 9th) or your scheduled headshot date.

“In 2018, the Miss Virginia Association of Fairs Pageant launched a pageant-wide community service project. In keeping with our focus on the importance of education, each contestant is encouraged to participate in “Read to Succeed”. Please consider bringing new books suitable for pre-K, Kindergarten, or 1st graders. The goal of “Read to Succeed” is to place a book on every desk of each new kindergarten student on the first day of school at several elementary schools across the state of Virginia... Be the change you wish to see in society. Let’s work together to help young Virginians succeed through the knowledge and love of reading. Just think- you might provide the first book a child has ever held in his or her hands.”

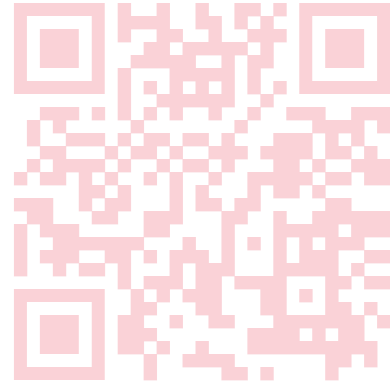

2024 RULES AND REGULATIONS:

Please read the following, as signing the application page acknowledges your agreement to these rules.

The 2024 Clarke County Fair Queens are also required to abide by these rules after receiving their title.

1. Contestants must be a Virginia resident and reside in the counties of either Clarke, Fauquier, Frederick, Loudoun, Shenandoah, or Warren.
2. Contestants must be female who has always been female, single, never married, without children, and never having been pregnant.
3. Contestants must possess strong moral character, have never been convicted of a crime, have any pending criminal charges, or have committed an act or engaged in an activity which is or could be characterized as dishonest, immoral, indecent, or in bad taste. These regulations also apply to improper images/actions on all social media outlets.
4. If a potential contestant has been suspended or expelled from school for behavioral/action-related matters at any point in time, they are **required** to disclose this information in full transparency to the pageant directors via a formal conversation to determine if they meet the requirements listed in line item #3 (see above). Ability to participate will be at the discretion of the CCFSP Directors and CCFA Board of Directors.
5. All contestants must enter the division corresponding with their age as of pageant day. All winners are required to sit out one (1) year; they will be eligible to compete again in the 2025 pageant if they have reached the minimum age for the next age division (contestants may not win the same title/age division twice).
6. Contestant line-up will be determined by the order applications are received in the fair office, not postmarked (first in, last out).
7. All Miss Division contestants are **required** to attend a mandatory orientation session immediately following all age contestant orientation on July 28th in the fair office. If unable to do so, advance notice must be provided.
8. Pre-Teen/Jr/Miss pageant contestants are **required** to attend a mandatory rehearsal Friday, August 2nd & Friday, August 9th from 7:30 - 10:00 PM. If unable to do so, advance notice must be provided.
9. The First Runner-Up in each age division must be willing to assume all duties if the winner is unable or unwilling to fulfill her duties.
 - In the event a 2024 titleholder is suspended or expelled from school for behavioral/action-related matters during her reign or involved in illegal activity, she will be required to forfeit her title (including crown, sash, and personalized gifts) immediately.

10. The 2024 titleholders are required to attend/participate/abide in/by the following:
 - The 2024 CCFSP Titleholder Meeting on Monday, August 12- after concluding the Young Miss pageant. Titleholders and parents will sign the 2024 titleholder agreement and the directors will review fair week activities, as well as general information about the coming year.
 - Other events/parades as requested by the Board of Directors, Pageant Committee, and Pageant Directors - such as Homecoming parade, local Christmas parade/events, Apple Blossom parade ect.
 - All appearances in Clarke County must be made with the fair crown/sash. All appearances outside of the county *should* be made with the fair title. All appearances *must* be presented to directors in advance for approval.
 - Miss Queen is required to attend fair board meetings (dates TBD)
 - Anytime titleholders are on Clarke County Fairgrounds property they must be in their titleholder sash/crown.
 - The new Miss Clarke County Fair is not permitted to compete in any other pageants between her crowning and the 2025 Miss Virginia Association of Fairs Scholarship Pageant. Details to follow.
11. The Miss Clarke County Fair \$1000 scholarship money will be awarded after the Queen has fulfilled all her duties at the end of her reign- this includes competing at the 2025 Miss Virginia Association of Fairs Pageant and being present to pass down the title at the 2025 Miss Clarke County Fair Scholarship Pageant.
12. All judging decisions are FINAL
13. The 2024 Miss Clarke County Fair will compete in the 2025 Miss Virginia Association of Fairs Scholarship Pageant, to be held the weekend of January 2-5 at The Williamsburg Lodge in Williamsburg, VA. The queen will work *strictly* with the Pageant Directors and assigned resources in preparation for state finals. Additional information about the Miss title will be discussed at the titleholder meeting with the new queen and her parents.
14. All contestants and family/guests must always conduct themselves in a proper manner throughout pageant weekend. Any display of uncooperative or unsportsmanlike conduct will result in immediate disqualification of the contestant and removal of the individuals from the property. Incidents will also be directed to the fair pageant committee/fair board with the potential of the individual(s) being banned from the scholarship pageant program as a contestant; this applies to incidents before/during/after the pageant, if related to the pageant/titleholders.

All rules, regulations, awards, schedules, and information pertaining to the pageant are subject to change at the discretion of the Pageant Directors, the Fair Pageant Committee, and the Fair Board of Directors, if necessary.

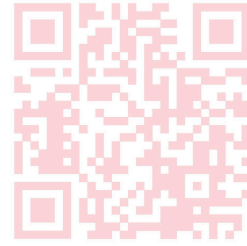

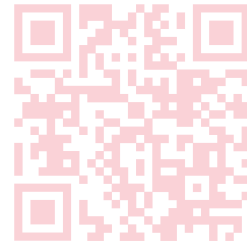

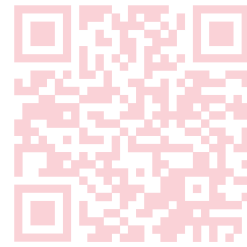
